- 1. City Engineer Update by Leo Foley, Veenstra and Kimm:
 - Spoke with the We Lead Structural Engineer that wrote the letter for WeLead and addressed his concerns about the
 structural support between the We Lead and City building. Leo communicated some of the items have been
 addressed such as the moisture concerns with partial demo. There are other items we are not in line with and have
 set a meeting with We Lead Director and We Lead engineer to discuss further. We look to have a telephone meeting
 within the next week.
 - Leo has recommended an Interim Grade II Water Plant Operator to assist with plant operations until we have filled the Grade II position. Currently the Interim is working for the Iowa City Water Company and although she doesn't operate the plant, she has the ability to administrate the compliance with official organizations. If they have guy that can run the plant, she can help and sign off. George stated that Danny Goodale can operate the plant. Leo has recommended we make it a priority to hire a replacement soon. Motion for Interim City Manager Geertz to enter an interim Grade II Water Plant Operator not to exceed current budget: 5-0 (Beranek/ McFerren)
 - In regards to Well #2 that sits inside the Power Plant, they are going to have DNR com and do an evaluation on it.
 That is going to happen Thursday at that same time they will take potential interim Grade II Operator, Chris from Iowa
