BUDGET WORK SESSION

City Council and Mayor held a budget work session at 6:30pm to discuss the police department and road use portion. This concludes the General Fund discussion. Following the budget work session, a presentation with Michael Hart of Northland Securities to discuss and review the refinance and additional funding for 2013A Bond. City will look to refinance the 2013A Library Bond in order to lower the interest rate but keep to the same payment plan. This will allow a savings of approximately 55,000 in interest. In addition, the City Hall/Police Department need major maintenance and space allocation updates. The Council has reviewed additional funds of \$400,000 to the bond.
